3. Wide and immediate dissemination of the contents of this Memorandum is hereby enjoined.



**REITERATION OF THE STRICT COMPLIANCE
WITH NO COLLECTION POLICY**



To: **ASSISTANT REGIONAL DIRECTOR
SCHOOLS DIVISION SUPERINTENDENTS
FUNCTIONAL DIVISION CHIEFS
ALL SCHOOL HEADS
ALL OTHERS CONCERNED**

1. This Department of Education MIMAROPA Regional Office strongly reiterates the directive on the strict implementation of the No Collection Policy, as stated in the Memorandum from the Office of the Secretary dated August 14, 2025, and pursuant to Republic Act No. 4206 as amended by Republic Act No. 5546.
2. Schools division offices and schools are enjoined to actively prohibit any form of collection, whether voluntary or otherwise, from learners, parents/guardians, and teachers. This includes the sale of tickets and/or the collection of contributions in any form with the exception of membership fees of school children in the Red Cross, the Girl Scouts of the Philippines and the Boy Scouts of the Philippines. In addition, schools must strictly implement the provisions of DepEd Order No. 13, s. 2022 or the Omnibus Guidelines on the Regulation of Operations of Parent-Teacher Associations, particularly on the allowable activities involving the students.
3. All DepEd teaching, non-teaching and teaching-related personnel are directed to enforce the No Collection Policy in all levels of governance. Failure to comply will be dealt with the appropriate administrative sanctions as provided for under DepEd Order No. 49, s. 2006 or the Revised Rules of Procedure of the Department of Education (DepEd) in Administrative Cases.


