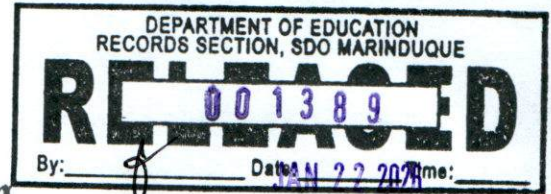

In pursuant to DM-OULS-2026-003, dated January 5, 2026, issued by the Office of the Undersecretary for Learning Systems, entitled "Extension of the Administration of the Computer-Based National Career Assessment Examination (CB-NCAE)," the Bureau of Education Assessment (BEA) approved the extension of the testing window to accommodate requests from field offices and to ensure the readiness of testing facilities, including computer capacity and internet connectivity.

In this regard, all concerned public and private secondary schools are hereby informed of the updated schedule for the administration of the CB-NCAE, as follows:

Activity	Original Schedule	Extension Period
CB-NCAE Testing Window	December 9, 2025 – January 30, 2026	February 1, 2026 – February 28, 2026

Pursuant to DepEd Memorandum No. 108, s. 2025 titled *Administration of the Computer-Based National Career Assessment Examination (CB-NCAE)*, and in compliance with DepEd Order No. 55, s. 2016 titled *Policy Guidelines on the National Assessment of Student Learning for the K to 12 Basic Education Program*, the Learning Systems Strand, through the Bureau of Education Assessment (BEA), announced the testing window of CB-NCAE on **December 9, 2025 to January 30, 2026**.

Moreover, this Bureau announces the **extension of the testing window for CB-NCAE** to public and private secondary schools operating with permit in consideration of the official requests received from Regional Offices (ROs) and Schools Division Offices (SDOs).

The extended testing window is as follows:

Testing Window	Extension Period
December 9, 2025 to January 30, 2026	February 1 to 28, 2026

The extended testing window allows the ROs and SDOs to administer the CB-NCAE within the inclusive dates indicated above in accordance with **DepEd Order No. 012, s. 2025**, titled *Multi-Year Implementing Guidelines on the School Calendar and Activities*, and taking into account the readiness of testing facilities, as well as the limitations in computer capacity and internet connectivity.

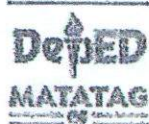
