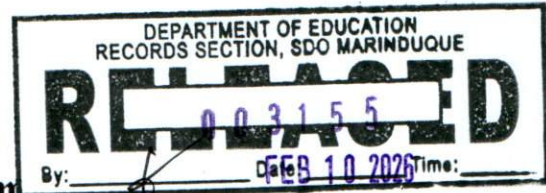

Please be guided by the following details and reminders:

1. The activity shall be separately held at Boac RHU II located in Brgy. Bantay, Boac, Marinduque and at the Sta Cruz Social Hall located in Brgy. Pag-asa, Sta Cruz.
2. The schedule of activity shall be:
  - a. RHU Boac II - February 11, 2026 from 8:00 AM until 2:00 PM
  - b. Sta Cruz Social Hall – February 12, 2026 from 8:00 AM until 2:00 PM
3. Doctors are available in the venue, so that doctor's referral is no longer needed.
4. Cholesterol test requires 10 - hour fasting.
5. Present office/school ID upon registration on-site.
6. Teacher-participants shall ensure that necessary arrangements shall be undertaken for the classes that will be affected, consistent to the provisions of "no disruption of classes" policy.

We will be distributing 50 tickets per municipality, or a total of 100 tickets for the two-day activity, intended for DepEd teachers who are in need of medical and dental assistance in the said municipalities.

Kindly see below services:

**SERVICES: WITH DOCTOR'S REFERRAL ONLY AND NO FASTING REQUIRED:**

1. **Xray** - Maximum of 100 patients
2. **ECG** - Maximum of 100 patients AGE: 40 yrs old and above
3. **Glucose Test / Random Blood Sugar** - Maximum of 50 patients
4. **Uric Test** - Maximum of 50 patients
5. **Cholesterol Test** - Maximum of 30 patients

**Medicines**- List of Medicines will be provided to the Doctors on the day of the activity.

**Dental Needle and anesthesia** for 100 patients for **tooth extraction dental service** only
