



Per DepEd Memorandum No. OASOPS-2023-149, from the Office of the Undersecretary for Operations, Private Schools may begin operation earlier than public schools, provided that classes open on the 1<sup>st</sup> day of June but not later than the last day of August.

Relative to this, Private Schools that will begin operation earlier than public schools must submit a **Letter of Intent** and a copy of the **School Calendar**, indorsed by the Schools Division Superintendent, through **OTHERS** of the Regional Online Application Portal ([qadoa.depedmimaroparegion.ph](http://qadoa.depedmimaroparegion.ph)).



SUBJECT : **ADVISORY ON THE OPENING OF CLASSES FOR SCHOOL YEAR 2023-2024 FOR PRIVATE SCHOOLS**

DATE : August 2, 2023

In view of the opening of classes for School Year 2023-2024, **private schools may begin operations earlier than public schools, provided that classes open on the 1<sup>st</sup> day of June but not later than the last day of August**, as stipulated in Republic Act (RA) No. 11480 or an act amending Section 3 of RA No. 7797, otherwise known as *An Act to Lengthen the School Calendar from Two Hundred (200) Days to Not More Than Two Hundred Twenty (220) Class Days*.

Likewise, private schools must submit their school calendar to their respective regional offices to validate the requirements.
