

1. The Learning Resource (LR) Portal is a web-based repository of learning, teaching, and professional development resources that can be accessed by various public and private users. It is also the official source of all approved DepEd-developed teaching and learning resources. Through this, registered users may view and download published materials. It is stated in item 8 of DepEd Order No. 76, s. 2011 that DepEd Officials, teaching and non-teaching personnel are enjoined to register at <http://lrnds.deped.gov.ph> in order to access the LR Portal.
2. In view of this, the School Library Designates (SLDs) are instructed to facilitate the updating and registration of all school teaching and non-teaching personnel in the LR Portal. Furthermore, an updated list of registered school personnel shall also be submitted by completing the google form at <https://tinyurl.com/LRPortalUpdateSDOMarinduque>.
