Pursuant to DILG Memorandum Circular No. 2023-156 with subject "National Youth Commission (NYC) Resolution Approving the Modified Guidelines on the Conduct of the Mandatory Trainings for Sangguniang Kabataan Officials and Local Youth Development Council (LYDC) Members pursuant to Section 29 of Republic Act. No. 10742, as amended by Republic Act No. 11768, the respective Municipal Training Teams headed by their designated Municipal Youth Development Officers (MYDOs) will be **conducting the Sangguniang Kabataan Mandatory Training (SKMT)** in their respective municipalities **from November 8 to 13, 2023.**


Moreover, the said Resolution also provides that SK officials who are currently enrolled in any school during the conduct of the mandatory training may be excused from attending their regular classes.
