

CAPACITY BUILDING FOR MIMAROPA DEPED PROGRAM PROVIDERS ON THE ACCREDITATION PROCESS OF PD PROGRAMS BY THE PROFESSIONAL REGULATION COMMISSION (PRC)

1. One of the thrusts of the Professional Regulation Commission is the effective implementation of Resolution No. 1032 or the Implementing Rules and Regulations (IRR) of R.A. 10912, otherwise known as the "Continuing Professional Development (CPD) Act of 2016," through the CPD Accreditation System (CPDAS). This Regional Office has initiated a campaign to orient the Department of Education MIMAROPA in applying as Provider of Continuing Professional Development (CPD) as well as provide guidance in having their Programs accredited by PRC.
2. The said initiative emanated from an observation made during the renewal of Professional Identification Cards (PICs) of LPTs Licensed Professional Teachers in the Region in which majority of the Seminar and Training Certificates presented were not PRC Accredited
3. In this regard, this Region in partnership with PRC MIMAROPA will conduct a capacity building activity for DepEd Program Providers on the accreditation process of Professional Development Programs on November 8-10, 2023 at a venue to be announced later.
4. This activity aims to guide the participants on the process of CPD Registration and Accreditation of Self-Directed Learning Activities to further assist the teachers in this professional growth and in the renewal of the PRC licenses.


