SUBJECT: **CALL FOR NOMINATION OF PARTICIPANTS FOR THE ONLINE FIELD VALIDATION OF THE CPPD PROGRAM OUTLINE FOR TEACHERS**

DATE: July 19, 2024

1. Per Memorandum DM-OUHROD-2024-1344 from the Office of the Undersecretary for Human Resource and Organizational Development, Mr. Wilfredo E. Cabral, Officer-in-Charge, dated July 12, 2024, an *Online Field Validation of the Career Progression Professional Development (CPPD) Program Outline for Teachers* shall be conducted by the Human Resource Development Division – National Educators Academy of the Philippines in the Region (HRDD NEAP-R) through the School Governance and Operations Division – Human Resource Development Section (SGOD-HRDS) from July 12 – August 2, 2024.
2. Out of one hundred and fifty (150) target participants from the MIMAROPA Region, fifty (50) participants were allocated to the Schools Division of Marinduque. They are expected to fully validate all seven (7) domains of the CPPD Program Outline for Teachers.
