

SUBJECT: **ADMINISTRATION OF THE NATIONAL LEARNING CAMP ASSESSMENT (NLCA) POSTTEST FOR GRADES 8 - 11**

DATE: July 29, 2024

1. In reference to DepEd Memorandum No. 040 s. 2024 titled Administration of the National Learning Camp Assessment (NLCA) and DepEd Memorandum BEA-2024-07-933 titled Administration of the NLCA Post-Test 2024, this Office informs all concerned on the conduct of NLCA Post-Test for Grades 8 to 11 public school learners for School Year 2024-2025 on July 30 to August 2, 2024.

2. This activity aims to determine the effectiveness of the learning camp intervention and the learning proficiencies of participating learners before and after the National Learning Camp.

3. In connection to this, the NLCA Post-Test will be administered to all Grade 8 to 11 learners for School Year 2024-2025 who **took the Pre-Test for NLCA** and **participated in the National Learning Camp** in all public schools.

4. The assessment will be computer-based and shall cover learning areas in English, Science and Mathematics. Each test item will measure varying levels of skills and competencies in a multiple-choice format using the English language.

Relative to this, all Grades 8 to 11 learners from all public schools should activate /access their DepEd LMS accounts using their official DepEd Microsoft accounts for the conduct of NLC Assessment. School ICT Coordinators / School Testing Coordinators should ensure that the learners have accessed the DepEd LMS platform before the test administration.
6. All expenses to be incurred relative to the administration of NLCA like purchase of additional wi-fi modem, cable and wiring materials and other related expenses that are eligible within the implementing guidelines shall be charged against the school MOOE fund while travelling expenses of the Division Key Testing Personnel and monitors and other incidental expenses shall be charged against Program Support Fund of NASBE subject to the usual auditing rules and regulations.
