

Dimensions of School-Based Management (SBM)

The video presentation shall be anchored on the context of the six dimensions of SBM as described:

1. Leadership

- involves teachers, parents, and the community in decision-making processes, ensuring shared responsibility
- empowers teachers and staff to take on leadership roles
- builds leadership capacity within the school

2. Governance and Accountability

- engages the parents, students, local government units' community members, and alumni are actively engaged in school governance, planning, and program implementation.
- manifest active and functioning School Governance Council (SGC) or Parent-Teacher Associations (PTAs) that participate in school governance.
- ensures development and regular updating of School Improvement Plans (SIP) with measurable objectives

3. Learning Environment

- puts premium on the good condition in the infrastructure and facilities such as the condition of the school buildings, classrooms, and other school facilities that can impact on the learning environment
- creates a responsive learning environment that supports every student's unique learning journey and prepares them for future success.
- upgrade facilities and acquire necessary learning materials to create a more conducive learning environment.

4. Human Resource and Team Development

- utilizes resources and management teams to support both the academic and personal development of students.
- uses resources effectively, and staff are supported and motivated to achieve the best outcomes for students.
- establishes partnerships with stakeholders and community organizations to support educational programs and enhance resources.

5. Curriculum and Teaching

- customizes the curriculum to meet local community needs and contextualized learning experiences.
- implements differentiated teaching strategies to address diverse student needs, learning styles, and abilities.
- develops innovative programs that continuously explore and adopts innovative practices, such as new technologies or teaching methods, to enhance learning and management processes

. 6. Finance and Resource Management and Mobilization

- demonstrates efficient use of financial resources, budget management, allocating resources to priority areas such as teacher training, learning materials, and infrastructure.
- utilizes strategies to diversify funding sources and ensure the financial sustainability of the school.
