1. In compliance with DM-OUOPS No. 2025-11-00442 from Malcolm S. Garma, Assistant Secretary, Officer-in-Charge, Office of the Undersecretary for Operations dated January 20, 2025, titled **Learner Government Elections for School Year (S.Y.) 2025-2026**, the Schools Division of Marinduque, through the School Governance and Operations Division-Youth Formation Section under Creating Tomorrow's School Today: SGOD 360° and Project Youth for N.A.T.I.O.N.
